Comment: The bill would require that, if an animal control officer identifies a dog as dangerous, the animal control officer must so notify all people who reside within 500 feet of where the dog resides. The bill would also specify that the owner of a dangerous dog is responsible for that dog whether or not the dog is under the owner's direct control at a particular time and that a person who keeps a dangerous dog as a therapy dog must have evidence that the dog has been trained to do work or perform tasks for the benefit of an individual with a disability.

Under the program, Maine residents who work in Maine after graduation from postsecondary school can apply to consolidate student loans at a single advantageous interest rate and employers that opt to pay up to 50% of their employees' annual loan repayment costs are authorized to treat those costs as expenses for tax purposes.

Title: An Act To Prohibit Female Genital Mutilation and To Provide Education and Outreach Regarding Female Genital Mutilation

Comment: This bill would make it a Class B crime to perform female genital mutilation on a female person under 18 years of age for nonmedical purposes. The bill would also make it a Class B crime for a parent, guardian or person who has immediate custody of a female person under 18 years of age to consent to or permit female genital mutilation of that female person for nonmedical purposes or for a person to remove the female person from the State for such a procedure. Under the provisions of the bill, it is not a defense that the female person, or the parent, guardian or person who has immediate custody of the female person, consented to the procedure, but it is a defense that the procedure was done for medical purposes. This bill also would direct the Department of Health and Human Services, within its existing resources, to administer community-based education and outreach to provide culturally specific services for communities in the State in which female genital mutilation of minors might be practiced.

              3. Affect human trafficking by establishing restrictions on viewing websites used for solicitation and facilitation of prostitution and human trafficking;  
              4. Protect consumers from inadvertently viewing child pornography;  
              5. Mitigate the harm caused by so-called revenge pornography; and  
              6. Establish a fine to be used to fund the Victims' Compensation Fund and fund other human trafficking prevention programs.

Title: An Act To Enhance Safety for Victims of Sexual Assault and Stalking

Comment: This bill would amend the law:

1. Governing remedies available to tenants who are victims of domestic violence, sexual assault or stalking by expanding the forms of acceptable documentation that may be provided to landlords to include police reports prepared in response to investigations of sexual assault or stalking, and copies of criminal complaints for, or indictments or convictions of, charges of sexual assault or stalking; and
2. To provide that a person is guilty of sexual misconduct with a child who is at least 14 years of age but not yet 16 years of age if the actor is at least 10 years older than the other person and knowingly displays or disseminates sexually explicit materials to the other person with the intent to encourage the other person to engage in a sexual act or sexual contact.

Local and state health and code enforcement officers would be authorized to examine, report on and require remediation for these defects. If a dispute arises concerning the withholding of rental amounts, it may be adjudicated in small claims court. Tenants under a lease would be entitled to attorney's fees and double damages if they prevail.
